The following provides the action taken by the Pardons Board at the meeting held on November 18, 2014.

### **Inmate Cases**

The Pardons Board has determined that Mr. Dixon meets the requirements necessary per NRS. 213.1215 section 2 subsection (b) & (c) and is eligible for a Mandatory Parole Release.

Sentence of Habitual Criminal (Greater) Life without parole commuted to time served & immediate parole eligibility on cs Attempt Grand Larceny of Motor Vehicle.

**Anthony Wright, NDOC # 63621**

Active sentence of Habitual Criminal (Greater) commuted to 24 to 60 months with a parole eligibility of March 1, 2015 followed by his consecutive/concurrent Habitual Criminal (Greater) also commuted to 24 to 60 months

Granted Compassionate Release upon approved release plan with Lifetime Supervision Pursuant to NRS 176.113.

**Otis Wynn, NDOC # 55496**

Remaining two consecutive sentences to run concurrent with active sentence.
